The Government has invested so much amount as grants and loans to these fishermen's co-operatives. May I know what is the reaction of the Government to such cooperative societies being formed and whether the Government have received any complaints •

(d) what kind of fertiliser is to be used per acre in each case; and

(e) whether Government propose to give facilities relating to easy credit, irrigation and electricity for tube-wells to the farmers growing their crops ?

THE DEPUTY MINISTER IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND COOPERATION (SHRI S. D. MISRA) : (a) to (e) A statement is laid on the Table of the Sabha.

STATEMENT

(a) Maize, Bajra and Jowar are the crops for which hybrid seeds are to be provided during 1966-67.

(b) The estimated requirements of each variety of the above crops are as under :—

Will the Minister of FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND COOPERATION be pleased to state :

(a) whether it is a fact that the scheme to introduce statutory rationing in urban centres with a population of one lakh and more has not yet been implemented in many centres ?

(b) if so, what are the reasons therefor; and

(c) when the scheme is expected to be implemented in full ?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICULTURE COMMUNITY DEVELOPMENT AND COOPERATION (SHRI P. GOVINDA MENON) : (a) Yes, Sir.

(b) and (c) Sufficient stocks of foodgrains have to be built up for maintaining regular supplies to the ration shops before the introduction of statutory rationing. This is being done in a phased manner and statutory rationing is also being extended gradually to more and more cities and towns. It is not possible to give any exact date by which the scheme will be implemented in full.
