THE MINISTER OF DEFENCE (SHRI Y. B. CHAVAN): UK Government have since the middle of March 1966 lifted all restrictions on supply of military equipment and stores on commercial basis. US Government have also relaxed from the middle of the February 1966 restrictions on commercial sales of non-lethal military equipment.

THE MINISTER OF DEFENCE (SHRI Y. B. CHAVAN) : Pakistani armed forces continue to be located a few miles on the Pakistan side of the International Border, across Jammu and Kashmir, Punjab, Rajasthan, Gujarat and the cease-fire line in Jammu and Kashmir.
