a suggestion for action.

SHRI M. N. KAUL: Whether he has considered it? It is in order.

SARDAR SWARAN SINGH: It is a very good suggestion and I myself have sometimes felt greatly embarrassed there is no Indian interpreter and I do insist that in the course of my talks with any foreign digni ary there is an Indian interpreter.

SHRI C. D. PANDE. As a rule our candidates for the IFS, know one two foreign languages French and German. But in the modern world there are more languages equally important like Russian, Spanish. Arabic and Chinese. As Mr. Kaul said, the people who go abroad are interpreted not by the Indians there but by the local people. My experience that in this country there are many people who can speak Arabic whose services can be utilised. When we went abroad we had to be interpreted foreigners. May I know, Sir, Government will take into consideration the question of creating a large cadre of Interpreters?

MR. CHAIRMAN: In the meantime the Question Hour is over.

SHRI C. D. PANDE: Along wih the I.F S. a separate subordina e cadre should be established for Interpreters.

However, the study is a long range one and, in view of its complex nature, will take many years to complete. Plans are also underway for more extensive investigations on the demographic aspects of the humans in high radiation areas.

(b) Yes, Sir. The studies on the effects on rats of natural radiation from the monazite areas, which have been carried out by Prof. Gruneberg in collaboration with scientists of the Atomic Energy Establishment, Trombay show no obvious evidence of genetic damage, as revealed by skeletal examinations.
