

SHRI DINESH SINGH : Presumably the hon. Member is referring to the arms that they have received from the United States under various Pacts. The United States Government has made it very clear to us on several occasions that the arms given to countries under these pacts are not to be resold or given to any other country without their permission and it is, therefore, unlikely that Iran would have given any of these to Pakistan, but as I said in all these matters it is very difficult for me to say anything categorically, except to believe what the Government has said.

DR. GOPAL SINGH : Is it one of the conditions of the Tashkent agreement that Pakistan shall buy arms from nowhere, nor shall we, or is it the case that if they are buying arms, we shall also buy arms from somewhere ?

SHRI DINESH SINGH : No, Sir. There is no ban on the purchase of arms.

#### MIZOS TRAINED BY PAKISTAN AND CHINA

Will the Minister of EXTERNAL AFFAIRS be pleased to state :

(a) whether Government are aware that the Government of Pakistan have at Roma in the Chittagong Hill tract a guerilla training centre where officers of the Pakistan Army and Chinese Guerilla experts have been training Mizos for guerilla operations against India;

(b) whether Government have been able to find out the sources from which the Mizo hostiles have acquired hand-grenades, automatic rifles, light machine-guns and other similar equipment; and

(c) what steps have been taken by Government to publicise all the information they possess in regard to the above matters?

tThe question was actually asked on the floor of the House by Shri Jairamdas Daulatram.

THE MINISTER OF EXTERNAL AFFAIRS (SARDAR SWARAN SINGH) :

(a) Government have seen reports in this regard but beyond the confirmation that Mizo rebels have set up training camps in East Pakistan, there is no information that Chinese experts are training Mizo guerillas. Pakistan has been denying giving any assistance to Mizo rebels.

(b) Mizo rebels are known to have crossed over into East Pakistan and returned from there with some arms and equipment

(c) Statements made in Parliament on these matters have received wide publicity.

SHRI JAIRAMDAS DAULATRAM: Have Government any objection to placing on the Table all the evidence in their possession in proof of this action of Pakistan, except what they may consider necessary to withhold from the point of view of national security ?

SARDAR SWARAN SINGH : This is a suggestion. We will certainly consider it, but when some talks are going on the present stage may be perhaps a little premature.

SHRI JAIRAMDAS DAULATRAM  
Talks between whom ?

SARDAR SWARAN SINGH : Talks not on this question of Mizos, but talks with Pakistan on several other matters.

SHRI S. SUPAKAR: May I know whether our civil or military intelligence had any information about the existence of such training centres and, if so, since how long these training centres have been in existence and if the Government had any information about these things prior to the Tashkent talks, whether this matter was not raised at Tashkent for diplomatic reasons ?

SARDAR SWARAN SINGH : We have information from reliable sources that there was one training camp near Roma police station in East Pakistan and we have also information that there are two other training camps, one in Rentlang in East Pakistan, about 25 miles south of Vaseitlang and another camp near the village of Romabazar (Rongthang River) in Kuagrashri in East Pakistan. We have information about these three.

SHRI S. SUPAKAR : I am sorry . . .

SARDAR SWARAN SINGH : You need not be sorry. I have not forgotten your question. In the latter part the hon. Member asked me whether we had this information when we went to Tashkent and whether this was specifically raised there. Now, in the Tashkent talks we did not go into these details because till the last moment we were not sure whether even on basic questions there would be agreement between India and Pakistan.

SHRI S. SUPAKAR : My question still

SHRI ARJUN ARORA : May I know what talks are going on between India and Pakistan ? The Minister said that talks were going on. As far as the country is concerned, it appears after the delegation of Ministers, led by the Foreign Minister to Pakistan on the 27th February Inst, no talks are going on.

SARDAR SWARAN SINGH : Sir, talks are not going on at Ministerial level, but there are several exchanges of notes and several matters are being taken up by the Pakistan Government with us and we have taken up several matters with the Pakistan Government through our High Commission. For instance, there is this discussion going on about the return of persons who have been captured and are still in custody. There are several other matters about which talks at diplomatic level are constantly being maintained.

SHRI RAJENDRA PRATAP SINHA: The hon. Minister has stated that there are three such training centres in East Pakistan. To the best of our knowledge this training is a continuous process, in spite of the talks that are going on at present at different levels. Now, firstly, I would like to know whether Government contemplates taking any action with a view to counteracting the guerilla activities of Pakistan in our territory. They are taking advantage of the political dissatisfaction there and they are taking guerilla action. Are we contemplating taking retaliatory measures to train guerillas for operation behind this front in East Pakistan not only on East Pakistan, but also in Tibet, because both China and Pakistan are training these guerillas for their own purposes ? I would like to know it

SARDAR SWARAN SINGH : Sir, the hon. Member has asked, first what action we have taken to meet the situation created by the training of Mizos in Pakistan. Now, obviously in the internal situation we have to deal with all these lawless elements, whether they get training inside the country or outside the country. We have already taken this up with the Pakistan Government and we have delivered notes to them complaining against this. As not unexpected, they are denying that any such training facilities are being provided. Now, Sir, about the second part, as to whether we intend to retaliate either against Tibetan territory or against Pakistan by training guerilla\*, we do not do things of this type and we have no intention of undertaking any such programme.

SHRI SURESH J. DESAI : May I know if it is a fact that the check-posts on the border between the Mizo district and Pakistan are so few and far between that there are easy communications between the underground Mizos in the Mizo district and those sheltering in Pakistan, and if the Government contemplate to increase the check-posts so that this communication between the underground Mizos and those sheltering in Pakistan is stopped ?

SARDAR SWARAN SINGH : It is a good suggestion. I will pass it on to the Home Ministry.

SHRI M. M. DHARIA : While replying to one of the supplementaries on this question No. 138 the hon. Minister made some reference to some talks with Pakistan. Of course they must be concerned with this subject. What are those talks ? May I know why the hon. Minister said that because of these talks it will not be possible to disclose this information ?

SARDAR SWARAN SINGH : I have tried to clarify, and if there is any doubt I would like to say it again that there are certain talks going on with them which are not connected with this question of Mizos. On this question I have further said that we have taken it up with the Pakistan Government and protested to them, giving precise information that this training facility is being provided by Pakistan in these various places which I have mentioned. That information I have already supplied. The

question, that was being put by Mr. Jairam-  
das Daulatram was as to whether I am  
prepared to disclose the entire evidence which  
has enabled us to come to this conclusion. I  
thought that was ...

SHRI JAIRAMDAS DAULATRAM : Not  
the entire thing. On this I allowed  
Government not to give us what they consider  
is not desirable to give from Government's  
point of view.

SARDAR SWARAN SINGH : I have  
already given as much information as I could.  
I have given you the information about the  
existence of these things. You cannot expect  
me to disclose the sources of information.  
That I am not prepared to give.

SHRI N. SRI RAMA RBDDY: Apart from  
training centres situated in East Pakistan and  
China to train up these Mizos, I would like to  
know whether it is not a fact that there is a lot  
of cooperation and co-ordination between  
Naga rebels and Mizo rebels, both training  
each other and both helping each other. As a  
matter of fact it is today reported that  
thousands of Nagas have crossed into Mizo  
Hills. I would like to know what he is going to  
say about that.

SARDAR SWARAN SINGH: I have not  
got much to say except to confirm what the  
suspicion of the hon. Member is.

SHRI ARJUN ARORA : May I know if the  
Government has considered the advisability of  
taking the country into confidence about the  
manner in which Pakistan is aiding and  
helping and abetting subversive elements in  
the country and publish a White Paper on the  
subject?

SARDAR SWARAN SINGH : Sir, this  
information I have already given; this is in  
important piece of information, the  
establishment of training centres for training  
Mizos. We have also kept the House informed  
from time to time about the help which the  
Nagas have been receiving in the form of  
arms, etc. We have always kept the House and  
the country fully informed with all  
information.

SHRI B. K. P. SINHA : The hon. Minister  
said that they have no idea to encourage  
insurgency either in Pakistan or

Tibet as a counter-measure. Moreover he has  
said that they are taking step\* on the  
diplomatic level to meet the situation That  
reminds me of a couplet of Akbar Allahabadi:

खींचो न कमानों को, न तलवार निकालो,  
जब तोप मुकाबिल हो तो अखबार निकालो ।

That means: Do not wield your bows and  
arrows; do not take out your sword when you  
are faced with big cannons; bring out  
newspapers to meet the challenge of the  
cannons.

AN HON. MEMBER : No atom bomb ?

SHRI D. K. P. SINHA: My question is,  
have the Government of India realised  
that the steps that they have taken to meet the  
challenge of guerilla warfare and the  
philosophy behind those steps are proving  
inadequate ? In the light of this is there any  
proposal to consider fresh measures and  
develop a new philosophy to meet the  
challenge by the Naga and Mizo rebels ?

SARDAR SWARAN SINGH: Sir, it is a  
highly philosophical question and the hon.  
Member has twice repeated some -sayings of  
some well-known people, Bismarck on an  
earlier occasion and now Akbar Allahabadi.  
But I do not see the connection of that with the  
question that he is putting. It will be  
absolutely wrong for any impression to be  
created that we are not taking adequate steps  
on all fronts, and we have to take action on all  
fronts. Even here the hon. Members have been  
pointing out that we should tell everybody,  
that we should publicise it. We have to take  
action on the publicity front and on the  
diplomatic front and also internally safeguard  
our integrity and continue our vigilance and  
our defence effort. These are not mutually  
exclusive and one should not adopt an attitude  
of laughing away these things. These are  
serious matters

श्री बिमलकुमार मन्नालालजी चौरङ्गिया :  
क्या श्रीमान् यह बतलायेंगे कि जैसा अभी  
बताया कि हम सब क्षेत्रों में पर्याप्त प्रयत्न कर  
रहे हैं जहाँ तक पब्लिसिटी का सवाल है  
लेकिन संसद के बहुत से सदस्य इस बात से

संतुष्ट नहीं है कि पाकिस्तान में जो नागाओं की ट्रेनिंग हो रही है उसकी पर्याप्त पब्लिसिटी की गई है, तो इससे हमें संतोष हो इस लिये इसके बारे में कोई विशेष कदम उठाने का प्रयत्न करेंगे? दूसरी बात यह है कि जो आप कहते हैं कि पाकिस्तान को हम प्रोटेस्ट नोट भेज रहे हैं और सब कुछ कर रहे हैं, इसके बावजूद पाकिस्तान इसके बारे में कोई ध्यान नहीं दे रहा है और वहाँ नागाज ट्रेनिंग ले रहे हैं, मीजोज ट्रेनिंग ले रहे हैं और फिर वे हमारे यहां पर आ कर गड़बड़ कर रहे हैं, तो क्या हमारी सरकार यह मानती है कि केवल यही स्टेप लेना पर्याप्त है और क्या शासन यह ठीक नहीं समझता कि भविष्य में इस तरह की बातें दोहराई न जायें, नागा और मीजो लोग हमारे यहां पर गड़बड़ न कर सकें और पाकिस्तान उनको ट्रेनिंग न दे सके? यदि शासन ऐसा समझता है तो क्या वह कोई विशेष कदम उठाने की योजना बना रहा है?

**सरदार स्वर्ण सिंह :** आपके मन में कोई ब्राडर आइडिया हो तो मुझे बता दें और मैं उसपर सोच लूंगा क्योंकि जो कुछ हम कर सकते हैं वह कर रहे हैं, पाकिस्तान के खिलाफ कोई शिकायत होती है तो वह उनके नोटिस में लाते हैं और उसमें बचाव करने के लिये हिन्दुस्तान में कड़े कदम उठाते हैं। इसके अलावा आपने शायद अपनी आखिरी मीटिंग में इसके मुताल्लिक बहुत चर्चा की है मगर हमारे लिये उसमें कोई बज्रनदार बात नहीं निकली। अब अगर कोई बज्रनदार बात हो तो उसको आप बता दें।

**SHRI V. M. CHORDIA :** This is Question Hour. If you will allow me, Sir, to suggest, I will suggest to him.

**SHRI MULKA GOVIND A REDDY :** May I know whether the Government is in a position to deny or confirm that one thousand hostile Nagas well trained with arms have crossed into Mizo Hills area from Pakistan and whether these infiltrators have come through Burma and

whether the border between Assam and East Pakistan and Burma has been sealed, and what steps the security forces are taking to prevent such happenings?

**SARDAR SWARAN SINGH :** It is a fact that Naga underground and Naga hostiles have been crossing over into Pakistan territory from time to time and they had also brought in arms. On one occasion when they were passing through the Burmese territory, they were intercepted by the Burmese security forces and they had to return to India and were not able to go into the Pakistan territory. We have information that the Burmese Government are also taking serious notice of this because no Government would like people illegally to move about with illegal arms in an unlawful manner, and they themselves are taking suitable action. Our security forces and our border police have also taken various steps to counteract the moves on their part. It is a fact no doubt that the trouble in the Mizo area has further complicated the situation and the growing co-operation between the Mizo hostiles and the Naga hostiles is a matter which is engaging the very serious attention of the Home Minister and of the Defence Ministry, and I am sure the Government is fully seized of this matter and it will take steps, both defensive and corrective, to meet the situation.

#### FORFEITURE OF PASSPORTS

**THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI DINESH SINGH) :** (a) Yes, Sir.
