TAKE-OVER OF INDUSTRIAL UNITS IN U.P.

- 143. SHRI RAM SINGH: Will the Minister of INDUSTRY be pleased to state:
- (a) whether it is a fact that the Government of U.P. have urged the Government of India to take-over some industrial units located in that State, and
- (b) if so, what action has been taken thereon?

THE MINISTER OF INDUSTRY (SHRI D. SANJIVAYYA) (a) and (b) The Government of U.P. have not recently urged the Government of India to take over any industrial unit located in that State. However, one textile mill and four sugar mills were taken over during the last 3 years under Government control on the recommendation of the State Government.

THE MINISTER OF COMMERCE (SHRI MANUBHAI SHAH) (a) Six industries have so far been set up in Nepal with private Indian capital. Three of these have gone into production and the remaining three are under construction

(b) H.M G. Nepal have no share participation in these industries though loans to 4 of the undermentioned industries have been advanced by the Nepal Industrial Development Corporation

THE MINISTER OF INDUSTRY (SHRI D. SANJIVAYYA) Facilities for the fabrication of a number of equipment required for the installation of fertilizer plants are being established or are proposed to be established in various public sector projects. These projects, when established, may be able to meet about seventy to eighty per cent. requirement of plant and equipment for fertilizer plants.
