(क) और (ख) बनारस में स्कूटर बनाने का एक कारखाना लगाने के लिए एक निजी पार्टी से मार्च, 1964 में प्रार्थना पत्र प्राप्त हुआ था लेकिन उस समय स्कूटर उद्योग के प्रतिबंधित सूची पर होने के कारण उसे अप्रैल, 1964 में रद्द कर दिया गया था। मार्च, 1965 में इस उद्योग से प्रतिबन्ध हटने पर उसी पार्टी ने 29 मार्च 1965 को एक नया प्रार्थनापत्र दिया। इस प्रार्थनापत्र पर इसी प्रकार के प्राप्त हुए अन्य प्रार्थना पत्रों के साथ अभी विवार हो रहा है।

STATEMENT

(a) and (b) The application from a private party for establishment of a scooter factory at Varanasi, received in March, 1964 was rejected in April, 1964 as the scooter industry was then on the banned list. After the ban on this industry was removed in March, 1965 the same party submitted a fresh application on 29th March 1965. This application is still under consideration along with several similar applications received from other parties.
