standards of international highways and a few sections only need to be constructed or up-graded. Work on most of these sections is in progress as part of the Five-Year Plans of the Central and State Governments concern ed. A bridge, two miles long, on Priority Route No. A-I over the river Sone at Dehri-on-Sone has recently been completed. With the completion of this bridge, this arterial route connecting Turkish/Iranian border with Viet-Nam and Singapur, has been completed within India. Work on some other roads, such as the Silchar-Imphal road, is in progress.

SUPREME COURT JUDGEMENT IN 'BLITZ' PUBLICATION OF EVIDENCE CASE

THE MINISTER OF STATE IN THE MINISTRY OF LAW (SHRI C. R. PATTA-BHIRAMAN):(a)Yes,Sir.

- (b) Tile petition was mainly dismissed on substantive grounds viz. that the order passed by the Learned Judge was within his jurisdiction and, therefore, there was no question of the Supreme Court exercising its extraordinary powers to issue a Writ under Art. 32.
- (c) The question does not arise, as the Supreme Court has generally upheld the principle of "open trial".
