#### AVRO 748

234. SHRI RAM SINGH : Will the Minister of DEFENCE be pleased to state :

(a) whether it is a fact that the Indian made Hawker Siddely (Avro) 748 assembled at Kanpur have been put to tests in U.K.; and

(b) if so, the results thereof ?

PRODUCTION IN THE MINISTRY OF DEFENCE (SHRI A. M. THOMAS) : (a) No, Sir. One HS-748 aircraft manufactured at Kanpur has been sent to UK for the installation of additional equipment necessary for its use as a civil passenger aircraft. This aircraft was fully tested and given the certificate of air-worthiness in Kanpur before it was sent to U.K. Other aircraft to be delivered to the Indian Airlines Corporation will be fitted with the additional equipment, in Kanpur.

#### VIOLATIONS BY PAKISTANI ARMY

Will the Minister of DEFENCE be pleased to state:

(a) whether there have been any border violations by the Pakistani Army along the borders of West Bengal, Punjab. Rajasthan, Assam and Tripura after the withdrawal of Armed forces in pursuance of the Tashkent declaration; and

(b) If so, the number of such violations in different sectors of the borders ?

THE MINISTER OF DEFENCE (SHRI Y. B. CHAVAN) : (a) and (b) Since the withdrawal of forces, there have been no violations by Pakistan army of these borders. But there have been five incidents where Pakistan Rangers/East Pakistan Rifles have violated our borders—one in Rajasthan, two in Assam, and one each in West Bengal and Tripura. Besides, Pakistani nationals, aided and abetted by East Pakistan Riflemen, violated Assam border on nine occasions.

#### PAPER PULP PROJECT IN SIKKIM

(a) whether Government propose to instal a paper pulp project in Sikkim;

(b) if so, whether the Indian technical team which visited Sikkim has submitted its report; and

(c) when this project will be taken up?

THE MINISTER OF EXTERNAL AFFAIRS (SARDAR SWARAN SINGH): (a) No, Sir.

(b) No team sponsored by the Government of India has visited Sikkim in this connection. The question of conducting a feasibility survey is separately under examination.

(c) This will depend on the feasibility survey and other relevant factors.
