THE MINISTER OF WORKS, HOUSING AND URBAN DEVELOPMENT (SHRI MEHR CHAND KHANNA) : (a) Yes.

(b) It will not be in the public interest to divulge the findings at this stage. Further action is under the consideration of the Delhi Administration.

(c) The complaint was received by the Police on the 19th September, 1964.

(d) I understand that those members of the Society who made enquiries have been informed of the position.

#### UNIT TRUST OF INDIA

\*305. SHRI SITARAM JAIPURIA : Will the Minister of FINANCE be pleased to state :

(a) whether it is a fact that there is no properly constituted investment committee for the Unit Trust of India; and

(b) if so, the reasons thereof ?

THE MINISTER OF FINANCE (SHRI SACHINDRA CHAUDHURI) : (a) and (b) The Executive Committee of the Unit Trust controls the investment policy of the Trust. As this Committee meets at regular and frequent intervals, and is empowered to take the necessary decisions, no separate investment committee is considered necessary.

#### GRANTING OF STIPENDS TO MEDICAL STUDENTS

\*306. SHRI N. PATRA : Will the Minister of HEALTH AND FAMILY PLANNING be pleased to state :

(a) whether there is any scheme under Government's consideration for granting educational stipends of Rs. 100 per mensem to all girl students joining the Medical Colleges; and

(b) if so, the details thereof ?

THE MINISTER OF HEALTH AND FAMILY PLANNING (DR. SUSHILA NAYAR) . (a) and (b) A scheme to award 500 scholarships each of Rs. 100 per month every year to women medical students undergoing M.B.B.S. Course has been started. The students will be required to execute a bond to serve in the Family Planning and Maternity and Child Welfare and Health Programmes under the Central/State Governments for a period equal to the period for which the scholarship is received by them.

(c) if the answer to parts (a) and (b) above be in the affirmative, what are the reasons for the additional expenditure of Rs. one crore ?]
