

(2) The State Drugs Control authorities were advised to weed out therapeutically non-essential drugs while recommending raw materials with a view to conserving raw materials, particularly Vitamins, the overages added by firms in vitamin products were restricted to the minimum.

(3) Government have been prevailing on firms to import only essential drugs.

(4) The list of Essential Drugs published in the Import Trade Control policy was revised to cover only the critically essential drugs so that established importers could import only those items. Barter deals and Export Promotion Scheme licences were also recommended to be made valid for the import of only critically essential drugs.

(5) Import licences for special drugs required for personal use were recommended.

Attempts are being made in collaboration with the C.S.I.R. to develop essential drugs from indigenous sources.

#### COMMITTEE TO CHECK PRICE RISE IN DELHI

\*309. SARDAR RAM SINGH : Will the Minister of FINANCE be pleased to state :

(a) whether it is a fact that a Committee has been set up to check price rise in Delhi;

(b) whether the Home Minister is associated with the Committee; and

(c) what steps are proposed to be taken by the Committee to achieve their objective ?

THE MINISTER OF FINANCE (SHRI SACHINDRA CHAUDHURI) : (a) A Committee of traders, industrialists and officials was set up, in the context of the emergency arising from the hostilities with Pakistan, to help in maintaining price stability.

(b) Yes, Sir.

(c) The Committee has not yet taken any decisions in this regard. However, statutory rationing has been introduced in Delhi in respect of essential commodities.

#### SHIFTING OF GOVERNMENT OFFICES

310. SHRIMATI TARA RAMCHANDRA SATHE : Will the Minister of WORKS, HOUSING AND URBAN DEVELOPMENT be pleased to refer to the reply given to Starred

question No. 430 in the Rajya Sabha on the 24th November, 1965 and state :

(a) when the Government offices, mentioned in the list referred to in reply to the above question are going to be shifted out of Delhi and to which place each is proposed to be shifted; and

(b) what are the reasons, if any, advanced by each such office against its being moved out of Delhi ?

THE MINISTER OF WORKS, HOUSING AND URBAN DEVELOPMENT (SHRI MEHR CHAND KHANNA) : (a) and (b) 13 out of the 16 offices mentioned in the list are proposed to be shifted to Faridabad. It has not yet been possible to shift these offices to Faridabad as the office accommodation constructed at that station has been allotted to meet emergent needs. When this accommodation becomes available the offices proposed for shifting to Faridabad will be shifted. One office has, however, been allotted some residential quarters for use as office accommodation temporarily and that office is in the process of shifting. Proposals as to whether some more offices could be shifted to residential quarters are being considered.

In the case of one of the remaining three offices, the Punjab Government has been requested to shift them out of the Capital by the 29th February, 1966. The cases of the other two offices are being reconsidered in view of the lack of suitable office and residential accommodation in Calcutta and Simla where the offices were proposed to be shifted.
