In what time the bills should be paid and whether bills running into lakhs of rupees should be paid without any scrutiny, as re gards that, I am afraid, as the Minister-incharge of this Department, I would have to take every possible precaution. I am sure even in regard to the suppliers, they have no grouse against the contractors, but I am afraid of any vigilance cases' being started against the Minister or the senior officers of this Ministry. That is No. 1. As regards the first part of the question, the amount of money that is now being spent on the Stationery Department of the Govern ment of India is rapidly rising. What I think is to decentralise this control. We are going to have four regional centres, in Calcutta, Madras, Delhi and Bombay. Thirdly, I saw the representatives of the Stationery Department in Calcutta only about a fortnight ago and I have promised them, I have assured them and I make a categorical statement before the House that their service interests shall lately and properly safeguarded.

DR. K. L. RAO: We only go by th tative allocation made by the hon. Ibrahim Sahib when a statement was laid on the 24th April, 1963 on the Table of the Rajya Sabha. According to that there is plenty of water still available for Maharashtra.

SHRIMATI SHAKUNTALA PARANJPYE: I would like to know the quantity of water that will go over to Bezwada after the gar Dam stage IT is completed.

DR. K. L. RAO: We are not in si now. We have only sanctioned stage I which involves utilisation of 264 T.M.C.

e. Will the Central Government make a special grant so that the work of the project completed as early as possible?

DR. K. L. RAO: The shortage of rice in Ka in a normal year, not in an abnormal year, is about half a million tonnes and we (\pect that the Nagarjunasagar project w ill be able to supply this amount of rice.

SHRI M. N. GOVINDAN NAIR: May I t now whether the Central Government have received any complaint from the State Government that adequate funds have not been allotted to the Nagarjunasagar proj< ct and also where the Chief Minister of Andhra Pradesh is not trying to bargain by withholding their surplus stock?

DR. K. L. RAO: It is true that the project has been dragging on for eleven years, though sanctioned in 1955. We are trying to get utilisation only this year and that also partially. It is all because we wanted a certain amount of funds to be allotted. With regard to the second part of the question, I am sorry I will not be able to answer that.

SHRI D. THENGARI: When was it i riginally proposed to complete this dam? If there is delay, what are the reasons?

DR. K. L. RAO: The reason for this delay is that we were not able to allocate sufficient amount of finance year after year.

SHRIMATI TARA RAMCHANDRA SATHE: Will the Government take into consideration the demand from Maharashtra before finalising the second stage?

DR. K. L. RAO: Quite so. We will keep that in view.

SHRI AKBAR AU KHAN: I am sorry that from what I could gather, the Minister is not replying directly to the question. In view of the food shortage, the Food Minister and everybody concerned and he also, all have admitted that the production of rice ihrough the Nagarjunasagar project will wipe away the deficit. What amount are you allocating so that this project may be completed at its earliest?

Du. K. L. RAO: It is obvious, as I said, that this project requires another Rs. 40 crores to Rs. 50 crores for completion, and the earlier the Government is able to allocate it the earlier it will be finished.
