

INQUIRIES AGAINST MUNDHRA FIRMS

•894. SHRI M. P. BHARGAVA: Will the Minister of LAW be pleased to state:

(a) whether under the provisions of the Companies Act, any inquiries are being held against any of the companies with which Shri Haridas Mundhra is connected;

(b) if the reply to part (a) above be in the affirmative, under what Sections of the Companies Act the inquiries are being held ; and

(c) whether any reports have been received thereon?

THE MINISTER OF LAW (SHRI G. S. PATHAK): (a) and (b) No Inspectors have been appointed under Section 235 or 237 or any other Section of the Companies Act to investigate into the affairs of any of the companies with which Shri Haridas Mundhra is connected. However, the accounts of Messrs Duncan Stratton & Co. Ltd., and of other companies with which it had business dealings are being examined under Section 209(4) of the Companies Act.

(c) No final report has been received.

ARREARS DUE FROM SUGAR FACTORIES

•895. SHRI M. C. SHAH: Will the Minister of FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND CO-OPERATION be pleased to state the arrears due from the sugar factories to the cane-growers by the end of February, 1966?

THE DEPUTY MINISTER IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND CO-OPERATION (SHRI ANNASAHIB SHINDE): Out of the total price of Rs. 105-79 crores of sugarcane purchased by sugar factories this year up to 28th February, 1966, Rs. 84-26 crores were paid and Rs. 21-53 crores were in arrears.
