THE MINISTER OF HEALTH AND FAMILY PLANNING (DR. SUSHILA NAYAR): (a) and (b) 1 Urban and 151 Rural Water Supply Schemes have been received from the Government of Madhya Pradesh so far. In addition the State Government have sent outline proposals with rough cost figures in respect of 11 urban water supply and sewerage schemes for preliminary advice on their feasibility.
