(c) No. Sir. Ships inside notified harbour areas are not allowed to operate their own wireless stations. All ships in harbour have to use the public telecommunication facilities for outside contacts.

(b) A block grant of Rs. 15,000 was given by the C.S.I.R. to the Convener of the Convention.
