which is necessary to be in India, which is considered important by the community, or is important from the cultural or spiritual point of view, we will certainly take up the matter and negotiate but, apart from negotiations, there is no other way of getting these back, and this is what is happening in the case of the India Office Library for ten years and yet a decision has not been arrived at.

MR, CHAIRMAN : The Question Hour is over.

WRITTEN ANSWERS TO QUESTIONS

INDIAN STUDENTS GOING TO UNITED STATES

*464, SHRI M. C. SHAH : Will the Minister of EDUCATION be pleased to state :

(a) whether it is a fact that most Indian students going to United States of America for advanced studies in technical institutions are required to undergo intensive training in English before they are permitted to join specific courses of study; and

(b) if so, the steps taken by Government to remove this difficulty?

THE MINISTER OF EDUCATION (SHRI M. C. CHAGLA): (a) It has been pointed out to the Government by our Embassy in the U.S.A. that some of our students going to the U.S.A. are beginning to face the disadvantage of not being able to follow their courses because of an inadequate knowledge of English. The universities in U.S.A. often insist on giving the students whose English is weak a course sometimes lasting several months in the English language before they are allowed to join their regular course. This difficulty is felt particularly with students coming from Gujarat.

(b) The Union Government has drawn the attention of the Government of Gujarat to this fact. That Government is considering the possibility of starting a special orientation course for students going to the U.S.A. RECOMMENDATIONS OF THE TALUKDAR
