

STEPS TO REDUCE RICE CONSUMPTION IN WHEAT AREAS

423. **SHRI D. THENGARI** : Will the Minister of FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT and COOPERATION be pleased to state :

(a) whether it is a fact that the Government of India propose to take steps to reduce consumption of rice in the wheat-eating areas in the country, such as Punjab, Uttar Pradesh, Rajasthan and Delhi so as to make more rice available in the rice-eating areas; and

(b) if so, what will be the approximate quantity of rice that can be saved immediately in this way ?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND COOPERATION (SHRI P. GOVINDA MENON) :

(a) Yes, Sir.

(b) The quantity likely to be saved cannot be assessed as yet.

EXPORT OF TIMBER

424. **SHRIMATI TARA RAMCHANDRA SATHE** : Will the Minister of FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT and COOPERATION be pleased to state :

(a) whether it is a fact that Government are exporting timber, used for building purposes, to Japan; and

(b) If so, what steps are being taken by Government to encourage plantation of timber-yielding trees in the country ?

THE DEPUTY MINISTER IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND COOPERATION (SHRI ANNASAHIB SHINDE) : (a) No timber is exported to Japan by Government. However, according to the information available a small quantity of constructional timber namely, Laurel and other hardwoods has been exported to Japan by the exporters.

(b) The State Governments are raising large scale plantations in successive Five Year Plans with a view to meeting the increasing demands of wood including timber in the country. During the current Plan, the States are expected to raise plantations over an area of about 8.7 lakhs acres. Under the Fourth Plan a target of raising plantations over an area of 18.00 lakhs acres has been proposed.

425. **श्री महाबीर दास** : क्या खाद्य, कृषि, सामुदायिक विकास और सहकार मंत्री यह बताने की कृपा करेंगे कि :

(क) क्या यह सच है कि उत्तर प्रदेश की सरकार ने केन्द्रीय सरकार से जंगली हाथियों का दमन करने के लिये, जो राज्य के लगभग सात जंगलों में उपद्रव मचा रहे हैं और फसलों को नुकसान पहुंचा रहे हैं, बन्दूकों खरीदने के वास्ते 2500 रुपये की कीमत की विदेशी मुद्रा की मांग की है; और

(ख) यदि उपरोक्त भाग (क) का उत्तर 'हां' हो, तो क्या राज्य सरकार को विदेशी मुद्रा की मंजूरी दे दी गई है और यदि उसकी मंजूरी नहीं दी गई है तो उसके क्या कारण हैं ?

425. **SHRI MAHABIR DASS** : Will the Minister of FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT and COOPERATION be pleased to state :

(a) whether it is a fact that the Government of Uttar Pradesh has asked for foreign exchange worth Rs. 2,500 from the Central Government for purchasing guns with a view to controlling wild elephants which are causing havoc in about seven forests of the State and damaging the crops; and

(b) if the answer to part (a) above be in affirmative, whether the foreign exchange has been granted to the State Government and if the same has not been granted, what are the reasons therefor ?

WHEAT SUPPLIES FROM U.S.A.

427. SHRI SITARAM JAIPURIA : Will the Minister of FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT and COOPERATION be pleased to state :

(a) the quantity of wheat purchased for India under PL-480 in U.S.A. in the month of February, 1966; and

(b) the quantity of wheat actually supplied to India during the same month ?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND COOPERATION (SHRI P. GOVINDA MENON) : (a) and (b) Contracts for the purchase of wheat are entered into with the suppliers in U.S.A. from time to time for subsequent delivery during stipulated periods. The contracts actually concluded during the month of February 1966 were for 11.9 lakh tonnes of wheat with the delivery periods February to April, 1966. The actual quantity of wheat shipped during February 1966 against the purchases in February and earlier months was 8.21 lakh tonnes.

CULTIVATION OF ROOT CROPS

428. SHRI SITARAM JAIPURIA : Will the Minister of FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT and COOPERATION be pleased to state :

(a) whether there is any proposal before the Government to promote cultivation of root crops;

(b) if the answer to part (a) above be in the affirmative, whether the Central Government have issued any instructions in this regard; and

(c) if so, what are the details of the proposal ?

THE DEPUTY MINISTER IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND COOPERATION (SHRI S. D. MISRA)

(a) and (b) Yes.

(c) The following measures have been taken to promote cultivation of root crops :

(i) Under the Special Development (Central) Programme, schemes for the production of certified disease-free seed potatoes have been sanctioned in various States during 1964-65 and 1965-66 at a cost of about Rs. 16.00 lakhs.

(ii) Cold Storages for storage of seed potatoes have been sanctioned in some States at a cost of Rs. 52.60 lakhs. A sum of Rs. 1 crore is likely to be provided to the States for this purpose during 1966-67.

(iii) Under the Emergency Food Production Drive, launched in 1965, the State Govts. have been requested to take up the cultivation of Tapioca and Sweet potatoes in an intensive way and to bring an additional area of about one lakh acres under potato cultivation during Rabi 1965-66.

429. SHRI RAM SAHAJ : Will the Minister of FOOD, AGRICULTURE, COMMUNITY
