THE MINISTER OF DEFENCE (SHRI Y. B. CHAVAN): Yes, Sir; but they are available from the Union Public Service Commission on payment of Re. 1 per form as heretofore.

#### **ANTI-FREEZE COOLANT FOR RADIATORS**

\*15. SHRI R. K. BHUWALKA: Will the Minister of DEFENCE be pleased to state:

(a) whether it is a fact that the Defence Research Laboratory (Materials), Kanpur, has evolved an antifreeze coolant for use in automobile radiators on high altitudes; and

(b) if so, what are the details thereof?

THE MINISTER OF DEFENCE PRODUCTION IN THE MINISTRY OF DEFENCE (SHRI A. M. THOMAS): (a) Yes, Sir.

(b) This indigenous anti-freeze coolant has been found satisfactory, both in laboratory tests and in field trials at high altitudes and has been accepted for Service use. This will save foreign exchange up to about Es. 0 lakhs per year.

#### **PAKISTANI INFILTRATORS IN JAMMU AND KASHMIR STATE**

Will the Minister of DEFENCE be pleased to state:

(a) whether all the infiltrators sent by Pakistan into Jammu and Kashmir and other border districts have since been captured, killed or driven out; and

(b) what is the number of those infiltrators who have either been captured or killed since the cease-fire came into force?

THE MINISTER OF DEFENCE (SHRI Y. B. CHAVAN): (a) No, Sir. A very large number of infiltrators have been killed in action, a large number have expatriated and several have been captured. However, odd infiltrators are still being discovered.

(b) It is not in public interest to disclose this information.

#### **GUARD OF HONOUR BY N.C.C.**

\*24. SHRI R. S. KHANDEKAR: Will the Minister of DEFENCE be pleased to state:

(a) whether it is a fact that the names of the heads of the educational institutions in the country are not included in the list of those to whom NCC can provide guard of honour on appropriate occasions; and

(b) if so, what are the reasons therefor?

THE MINISTER OF DEFENCE (SHRI Y. B. CHAVAN): (a) The Chancellor of a University, and when attending as Chief Guests, the Pro-Chancellor and the Vice-Chancellor of a University, are provided guards of honour on appropriate occasions.
