In the question it has been asked whether we have received the report. I say we have seen the report, two reports, one for Western India and another for Northern India

SHRI M. P. BHARGAVA : So am I to take it that the reports have been received but they have not been considered by the Government of India yet? If so, what are the reasons, and when were the reports received?

SHRI L. N. MISHRA : Sir, as you know, the National Council of Applied Economic Research makes surveys oi so many subjects in the country, and so far as this subject of Power is concerned, they have taken a regional view of the position; they have not taken an overall view of the country's economy. As I taid, they have submitted two reports and we; are studying these two reports.

SHRI M. P. BHARGAVA: What steps are being taken by the Government to implement the recommendations of the Energy Survey Committee, and if no steps have so far been taken, at what stage it is under the consideration of the Government?

SHRI L. N. MISHRA : As has been earlier stated in the original answer, the Report of the Energy Survey Committee has been just received and it is under study. It is difficult to say anything further at this stage.

SHRI I. K. GUJRAL: The hon. Minister is keeoms himself behind very vague replies. The Energy Survey Committee report has been produced by the specialists in this nation, and it really outlines the progress that the nation can make in the next four years. May I

this House that he will appoint a really high-powered committee immediately to recommend finally as to what is the outline of Government's programme in so far as energy programme is concerned ?

SHRI L. N. MISHRA : It is not possible for me to give any assurance at this stage about the appointment of a highpowered committee, but I may say that the Planning Commission has already got a Perspective Division, and the N.R. Division also, which have been studying this subject. And so far as this report of the Committee is concerned, of course it will get all the due attention.

SHIFTING OF DAIRIES

*565. SHRIMATI LALITHA (RAJAGAPALAN) :f SHRIMATI TARA RAM-CHANDRA SATHE:

Will the Minister of WORKS, HOUS-ING AND URBAN DEVELOPMENT be pleased to refer to the reply given to Starred Question No. 628 in the Rajya Sabha on the 15th September, 1965 and state :

(a) whether the details of the regular scheme for shifting of dairies from Delhi have since been finalised; and

(b) if so, what are those details ?

MINISTER OF WORKS. THE HOUSING AND URBAN DEVELOP-MENT (SHRI MEHR CHAND KHANNA) : (a) and (b) The Ad-hoc (Slum Clearance and Improvement) Committee of the Municipal Coroora-tion of Delhi set up a Committee in February 1965, consisting of the representatives of the Municipal Corporation of Delhi, the Delhi Development Authority, the Delhi Milk Scheme and the Ministry of Works and Housing to go into the question of the pattern of development of ghosi colonies (dairies) in Delhi and

other allied matters. A representative of the Delhi Administration was also coopted with the Committee. The Committee has subm tted its report to the Commissioner, Municipal Corporation of Delhi. The report is to be considered at a meeting of the Ad-hoc (Slum Clearance and Improvement) Committee of the Corporation, to be held shoitly.

SHRIMATI LALITHA (RAJAGO-PALAN): Will the hon. Minister kindly say how long this Committee will take to consider this matter and when it will be finalised?

SHRI MEHR CHAND KHANNA : A meeting of the Committee is likely to be held shortly and it will not take much time

SHRI SANTOKH SINGH : Could the hon. Minister make a very rough estimate as to when these dairies are going to be shifted from Delhi which have been in existence for the last sixteen years or so? May I know if he can make a rough estimate as to how much t'me it would take to shift these dairies?

SHRI MEHR CHAND KHANNA : Possibly not in my lfetime but certainly within the lifetime of the questioner.
