1965, felt that several financial and technical collaboration agreements entered into in the past by Indian firms with foreign parties came in the way of exports of products manufactured under such agreements, and recommended that a Committee should be ret up to study foreign c'ollaboration agreements and modifications and changes in such agreements from the export angle. Government have accepted the recommendation and have accordingly set up a Committee for the purpose under the Chairmanship of Shri A. Ramaswami Mudaliar.

TIMBER PROCESSING FACTORY IN MYSORK

- 39. SHRI A. D. MANI: Will the Minister of INDUSTRY be pleased to rtate:
- (a) whether it is a tact that ths Government of Mysore is going to ret up a timber processing factory for purposes of export to Japan;
- (b) il so, whether Government of India have been consulted on the project; and
- (c) if the answer to part (b) above be in affirmative, what are the salient features of the project0

THE MINISTER OF INDUSTRY (SHRI D. SANJIVAYYA): (a) I am not aware of any such scheme of the Mysore Government.

(b) and (c). Do not arise.

BOKARO STEEL PROJECT

SHRI A. D. MANI: SHRI SITARAM J AIPURIA:

Will the Minister of IRON AND STEEL be pleased to state:

- (a) whether any estimates have been arrived at regarding the cost of the Bokaro Steel Project;
- (b) whether the Russian experts have submitted any recommendations Government on the subject;

(c) whether the report on the pro ject has been received by the Govern ment;

to Ouestions

- (d) if so, what are the salient features thereof: and
- (e) when the first phase of tha Project is expected to be completed?

THE MINISTER OF IRON AND STEEL (SHRI T. N. SINGH): (a) to (e). The detailed Project Report for the Bokaro Steel Plant has been received from the Soviet authorities. The Report envisages the setting up of an integrated steel plant with an initial capacity of 1.7 million tonnes per annum capable of being developed continuously to a capacity of 4 million tonnes per annum and to 5.5 million tonnes ultimately. The cost is estimated to be Rs. 770 crores by the Soviet designers at the 4 million tonne stage but this estimate exclude certain off-site facilities, etc.

The plant will produce hot and cold rolled sheets and galvanised sheets, both plain and corrugated.

According to the Project report, the first phase 'of the project is expected to be ready in M years, but this question of the phasing is under discussion with the Soviet Organisations concerned.

TEXTILE MILLS UNDER LIQUIDATION
