the firemen of both the engines were killed. The accident was due to the failure of railway staff.

## CONVERSION OF METRE GAUGE RAILWAY LINE BETWEEN RENIGUNTA AND THIRUPATHY TO BROAD GAUGE

- 68. SHRI Y. A. REDDY: Will the Minister of RAILWAYS be pleased to state:
- (a) whether Government received any representation for the conversion of the metre gauge Railway line between Renigunta and Thirupathy into broad gauge; and
- (b) if so, what action has been taken in the matter?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI SHAM NATH): (a) Till some time back, several representations were received from time to time, for conversion of Reniguntai-Tirupati metre

gauge section into broad gauge (6:1 miles/10 KMs.)

(b) The question of conversion of this metre gauge section into broad gauge was considered on several occasions in the past, and found not financially justified. An appreciation made by the Southern Railway in 1960 revealed that neither the laying of a separate broad gauge ln;e, nor conversion into mixed gauge, would be financially remunerative. From the operational angle also, the capacity of the metre gauge section was considered adequate to meet the demands of traffic. Moreover, extension of broad gauge line to Tirupati will not serve the main purpose intended, that of removing the transhipment difficulties of pilgrim passengers, who wiH nevertheless be required to change trains at Renigunta, from main line trains for the branch line. The conveision is thus not justified, ei her on financial, or traffic, or operational considerations.
