REPORT OF THE CHAIRMAN OF NATIONAL SHIPPING BOARD ON KERALA PORTS

- 109. SHRI P. K. KUMARAN: Will the Minister of TRANSPORT, AVIATION, SHIPPING AND TOURISM be pleased to state:
- (a) whether the Chairman of the National Shipping Board has submit ted any report Io Govern-ment after visiting the sea ports of Kerala; and
- (b) if so, what are his specific sug gestions for improving the ports on the Kerala coast'.'

THE MINISTER OF TRANSPORT, AVIATION, SHIPPING AND TOURISM (SHRI N. SANJIVA REDDY): (a) The Chairman, National Shipping Board, visited certain intermediate and minor ports of Kerala in October, L965.

- (b) The suggestions were as follows:
 - (1) Foodgrain and fertiliser imports for the hinterland of Trivandrum should he through Trivandrum port.
 - (2) Alleppy Port should be improved by providing two new tugs, effecting repairs to piers and installing additional electric cranes.
 - (3) The insurance rates charged by Indian Insurance Companies on coastal cargo are unduly high and should be reduced.
 - (4) Radio communication bet ween shore and ships at Alleppy should be installed.
 - (5) The development of a deep water all-weather port at Beypore will be of benefit to the country.
 - (6) Badagara exports were suffering due to coastal vessels not calling at the port.
 - (7) At Cannanore, the fishing wharf now being developed

- could be utilised for handling the commercial traffic.
- (8) The bar at Azhikkal should be dredged to 20 feet to enable small steamers to come inside the shelter of the river.

The suggestions have been brought to the notice of the State Government and other concerned authorities for consideration.

- Australia.—A contribution of 8 million Australian dollars to be utilised on purchase of wheat, foodstuffs, handling and storage equipment and pesticides.
- Austria.—Milk powder and fertilisers worth \$ 1,000,000.
- Canada.—An aid of \$ 15 million for the import of wheat, wheatflour, dried peas and milk powder.
