delivery towards the end of 1966. The cost of these two aircraft, excluding spares, is estimated at Rs. 314 lakhs.

Air India are not replacing the Boeing they lost in January, 1966 as the Boeing which they were purchasing for charter to Indian Airlines Corporation will now be taken into their own service.]

## FALL IN GUR PRICES

\*650. SHRI SITARAM JAIPURIA: Will the Minister of FOOD, AGRI-CULTURE, COMMUNITY DEVELOPMENT AND COOPERATION be pleased to state:

- (a) whether the Central Government have received any information from the Government of Uttar Pradesh to the effect that gur prices have fallen in the State;
  - (b) if so, the reasons for the fall; and
  - (c) the steps taken in the matter?

THE DEPUTY MINISTER IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND COOPERATION (SHRI ANNASAHIB SHINDE): (a) Yes, Sir. The Uttar Pradesh Government brought to the notice of the Central Government in the middle of February the downward trend in gur prices in the State.

- (b) The reasons for the fall were the increased sugarcane supply and correspondingly increased production of sugar.
- (c) The gur prices have since then shown an upward trend from the first week of March.
