THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI B. R. BHAGAT): (a) Yes. Sir.

- (b) So far 3 patrol boats have been released for shipment to Pakistan.
 - (c) Yes, Sir.
- (d) No US AID cargo has so far reached India from Pakistan.

*157. SHRI P. K. KUMARAN: Will the Minister of PLANNING be pleased to state:

- (a) whether it is a fact that Study Group of the Panel on Labour Policy of the Planning Commission has recommended ballot among workers for determining the representative character of trade unions; and

†INDUSTRIALISTS' MEETING WITH THE LATE PRIME MINISTER

- *29. SHRI S. S. MARISWAMY: Will the Minister of FINANCE be pleased to state:
- (a) whether it is a fact that a 12member delegation of the Federation of Indian Chambers of Commerce and Industry met the late Prime Minister in December, 1965 and explained to him the difficulties hampering industrial production in the country; and
- (b) if so, what are the reactions of the Government of India in the matter?

THE MINISTER OF FINANCE (SHRI SACHINDRA CHAUDHURI): (a) Yes, Sir, a delegation of the Federation of Indian Chambers of Commerce and Industry waited late Prime Minister to explain to him their difficulties which were stated to hamper industrial production in country.

(b) Government are aware of some difficulties in the way of industrial production and are constantly endeavouring to remove them.
