SHRI AKBAR ALI KHAN: May I know, Sir, if there is any proposal, in view if the heavy traffic from Hyderabad to Delhi, of running a direct train from Hyderabad to Delhi?

DR RAM SUBHAG SINGH: We are going to introduce a direct train between Hyderebad and Madras from 1st April, but regarding Delhi, from Kazipet there are some bogies which go to Hyderabad. It all depends on the quantum of traffic. Later on this will be considered. But for the time being we have a direct train between Hyderabad and Madras.

SHRI AKBAR ALI KHAN: You have a train from Madras to Delhi. Can you not have one train from Hyderabad to Delhi?

DR. RAM SUBHAG SINGH: This is a suggestion which will be considered at the appropriate time.

DUES OF THE STATE OF ORISSA OUTSTANDING AGAINST HINDU-STHAN STEEL LIMITED

*193 SHRI S. SUPARKAR: Will the Minister of IRON AND STEEL be pleased to state.

- (a) whether a large amount is due from the Hindusthan Steel Limited at Rourkela to the State of Orissa on various accounts like the supply of electricity; and
- (b) If so, the period for which the amount i_S outstanding?

THE DEPUTY MINISTER IN THE MINISTRY OF IRON AND STEEL (SHRI P C. SETHI): (a) and (b) In respect of transfer of energy from the State Electricity Board to the Steel Plant, the payment has already been made. However on receipt of this payment the State Government indicated a further sum of Rs. 4.49

lakhs still outstanding for some back period. The Steel Plant has called for details of this amount and will settle the account on reconciliation of details when received.

A sum of Rs. 98.5 lakhs was claimed by the State Government as duty payable by the Rourkela Steel Plant on electricity generated by the Steel Plant but the latter, after obtaining advice, contended amount was not due. The matter has been referred to the Chief Minister of Orissa by the then Minister Steel and Mines and is under State Government's consideration. However following a threat by the State auto discontinue electricity supply to the steel plant, the Rourkela Steel Plant had to make a payment of Rs. 65 lakhs in all.
