#### REDUCTION OF CRUDE OIL PRICES

SHRI S. S. MARISWAMY:

Will the Minister of PETROLEUM AND CHEMICALS be pleased to state:

(a) whether it is a fact that two oil companies have agreed to effect a cut in price of crude oil; and

(b) if so, what are the details in this respect; and whether, it is in consonance with the recommendations of the Talukdar Committee?

THE MINISTER OF PETROLEUM AND CHEMICALS (SHRI O. V. ALAGESAN): (a) Yes, Sir, with effect from the 1st January, 1966.

(b) Burmah-Shell and Caltex have offered a further discount of 8 cents per barrel on light Iranian Crude Oil effective from the 1st January, 1966, making the current price as \$1.40/ barrel. The total discount now comes to 38 cents per barrel as against 40 cents suggested by the Talukdar Working Group on Oil Prices.

ESSO have offered a further discount of 4 cents on their Arabian Crude Mix as from the same date, making a current price of \$1.36/barrel. No com-

parable figure appears in the report of the Working Group for this crude mixture.

#### FERTILIZER FACTORY AT NAMRUP (ASSAM)

(a) whether it is a fact that a fertilizer factory has been set up by the Fertilizer Corporation of India at Namrup in Dibrugarh District in Assam; and
