189. SHRI B. N. BHARGAVA: Will the Minister of LABOUR, EMPLOYMENT AND REHABILITATION be pleased to state whether the factory workers are entitled to casual leave, and if not, whether it is proposed to make provision for such leave?]

श्रम, सेवानियोजन और पुनर्वास मंत्री (श्री जगजीवन राम) : कारखाना अधिनियम, 1948 के अधीन कारखानों के मजदूर सवेतन वार्षिक छुट्टी के हकदार है। आकस्मिक छुट्टी के बारे में कोई सांविधिक व्यवस्था नहीं है और न ही इस प्रकार की व्यवस्था करने का कोई विचार है। प्रतिष्ठान में आकस्मिक छुट्टी सेवा शक्तों, द्विपक्षीय समझौतों, आदि के अनुसार मंजूर की जाती है।

†[THE MINISTER OF LABOUR, EMPLOYMENT AND REHABILITATION (SHRI JAGJIVAN RAM): Under the Factories Act, 1948, factory workers are entitled to annual leave with wages. There is no statutory provision in regard to casual leave, nor is there any proposal for making such a provision. Grant of casual leave in any establishment is regulated by the terms and conditions of service, bipartite agreements, etc.]

**PRODUCTION OF IRON WITH NON-COKING
COALS**

- (a) whether the Central Fuel Research Institute at Jealgora has developed any new process of production of iron with non-coking coals; and
- (b) if so, the details thereof?

THE MINISTER OF EDUCATION (SHRI M. C. CHAGLA): (a) No, Sir. The Central Fuel Research Institute, Jealgora has, in fact, developed a process for making a substitute for metallurgical coke from non-coking coal incorporating at the same time some of the raw materials for iron making.
