is presumably referring to the Emergency Production drive undertaken during the current year (1965-66). From the reports received from the it appears that State Governments, against a target of 3.29 million acres, area expected to be the estimated cultivation brought under during kharif and rabi of 1966 is 3.8 million acres. It is not possible at this stage to indicate the quantities of additional production of foodgrains. A gramme of High Yielding Varieties of foodgrains (Paddy, Wheat, Jowar and Bajra) has been drawn up for a total area of 4.88 million acres in number of States for the year 1966-67. Preparatory steps for this programme are under way.

written Answers

- (b) Yes, Sir. There is a shortage of engines for the expansion of Lift Irrigation. An assessment of requiments of manufacture of engines of various kinds for the second half of the current year and for the next year has been made and steps are being taken to release the raw material and the extra foreign exchange required for stepping up manufacture.
