Oral Answers

SHRI M. M. DHARIA: While appreciating the view expressed by the hon. Minister that the procurement was possible because of these State zones, is it not a fact that the mobility of foodgrains was altogether stopped, and because there is not a single uniform policy of procurement throughout the States in the country it has affected the procurement as

SHRI C. SUBRAMANIAM: With regard to inter-State movement, it should not be left for free trade to function. The inter-State movement should be only on a Government to Government basis. We also tried to fix the surplus available in the surplus States. It was on that basis that procurement was undertaken on behalf of the Central Government. The target fixed on that basis was 19 lakh tonnes to be procured. But the actual procurement came up to 16-5 lakh tonnes only. There was only a shortfall of 2-5 lakh tonnes.

SHRI P. K. KUMARAN: The hon. Minister said that after the introduction of the zone¹ system, procurement has improved. May I know what steps are taken for procurement from the surplus districts? I am specifically mentioning the surplus districts of Andhra, that is, Krishna, West Godavari and East Godavari. The Food Corporation is not purchasing direct and the millers are asked to purchase. The millers do not purchase with the result that the peasants are not disposing of their grain. That is the actual: situation today. The millers are not prepared to purchase at the rate fixed by the Government. At the same time there are scarcity conditions prevailing in the other parts of India. May I know what steps the Government are taking in this connection? Why not the Food Corporation be made to purchase direct from the peasants?

SHRI C. SUBRAMANIAM: The procurement in the coastal districts of Andhra is on the basis of procurement through millers, not direct from the producers. The procurement through the millers particularly during the last month and this month has been quite satisfactory. I have not received reports that the purchases are not being made by the millers, but since the hon. Member mentions it, I shall try to find out the situation.

SUBRAMANIAM: It had not been possible to get figures, accurate statistics, with regard to the cost of production because it varies from area to area, and studies are under way now to get the figures. SHRI C. SUBRAMANIAM: I have already stated that accurate statistics are not available with regard to the cost of production. Even with regard to marginal lands it varies from area to area, and therefore the studies are wider way now. A_s soon as they are available they will be taken into consideration for the purpose of fix-

ing the prices. But even here what we have done is we have only indicated the minimum support price. As a matter of fact the procurement price of the various State Governments is much higher than the support price which we have indicated.
