(b) The Government of India have promulgated the Drugs (Control of Prices) Order 1963 pegging the prices of drugs to those obtaining on 1st April, 1963. Prosecutions are launched by the State Governments against contraventions of this order. The question of amending the Drugs (Control of Prices) Order 1963, so as to cover formulations and packings marketted after 1st April, 1963 is under consideration of Government of India.
