**MESSAGE FROM THE LOK SABHA  
THE MERCHANT SHIPPING (AMENDMENT)  
BILL, 1966.**

SECRETARY : Sir, I have to report to the House the following messages received from the Lok Sabha, signed by the Secretary of the Lok Sabha :—

"I am directed to inform Rajya Sabha that the Merchant Shipping (Amendment) Bill, 1966, which was passed by

Rajya Sabha at its sitting held on the 7th April, 1966, has been passed by Lok Sabha at its sitting held on the 27th July, 1966, with the following amendments :—

*Clause 1*

1. 'Page 1, for lines 5 and 6, substitute "(2) It shall be deemed to have come into force on the 28th day of May, 1966."

*Clauses 40 and 41 {Sew}*

2. 'Page 23, after line 8, insert—

40. "Certain contraventions etc. not to be offences.—Notwithstanding the retrospective operation of this Act, no contravention of, or no failure to comply with, any of the provisions of the principal Act, as amended by this Act, shall render any person guilty of any offence if such contravention or failure—

(i) relates either to any provision inserted in the principal Act by this Act, or to any existing provision thereof as amended by this Act and

(ii) occurred on or after the 28th day of May, 1966 and before the 6th day of June, 1966.

41. *Repeal and saving.*—(1) The Merchant Shipping (Amendment) Ordinance, 1966 (No. 3 of 1966) is hereby repealed.

(2) Notwithstanding such repeal, anything done or any action taken under the said Ordinance shall be deemed to have been done or taken under this Act."

2. I am, therefore, to return herewith the said Bill in accordance with the provisions of rule 121 of the Rules or Procedure and Conduct of Business in Lok Sabha with the request that the concurrence of Rajya Sabha in the said amendments be communicated to Lok Sabha." Sir, I lay the Bill on the Table.
