SHRI BHUPESH GUPTA (West Bengal) : Sir, I have given notice of two things. One is pending before you about the statement reported yesterday. I think the hon. Minister will make a statement regarding the Left Communists.

Another—I think Mr. Sinha has also given notice—is about calling out the Military in Shillong and firing on the students and so on. It is a serious matter. The matter has been going on for some time and Government up till now has not made a statement. The Central Government comes in because the border security forces are being deployed and being used to shoot down students and other people, and also the Military has been called out and the administration of Shillong has been taken over by the Military. I do not wish to say anything very much on this subject except that it is exercising the minds of many people here, and Government should make a statement; if possible, Government should send its officials to bring information and also see that this kind of repression is stopped against the people there.

With regard to the other matter, I think he will make a statement. I need not say anything more.
