(a) whether any application or notice has been received from the residents of Churu-Fatehpur (Shekhawati) section of the Railways wherein they have protested against charging double Railway fare from the passengers travelling on that section; and

(b) if so, what action is being taken by Government in this regard ?]

MANUFACTURE OF TRACTORS IN COLLABORATION WITH USSR
