This is considered to b_e a very fair and equitable step in the context of comparatively smaller volume of trade transacted between India and each ol these countires in comparison with the volume of Indo-U.S.SR. trade. Protocols exchanged with most of these countries have already been placed in the Parliament Library.

Written Answers

8. It may further be mentioned that most of the East European countries arc agreeable not only to maintain current level of trade with India but also to expand it continuously during the coming years.

9. It may also be noted that future contracts will be entered into on the basis of ruling prices which must be internationally competitive and also on the basis of quality and specifications being acceptable to the importer. In other words, the escalation agreed to in these Protocols will only relate to existing contracts which were valued on 6.6-1966 and will not debar both India and the East European countries from taking advantage of future trends in prices in the transactions between the two countries.

THE MINISTER OF INDUSTRY (SHRI D. SANJIVAYYA): (a) to (c). Under the scheme of decontrol, Government makes allotment of cement only for supplies to Government Departments/Organisations under th© rate contract, for which 50 per cent, of total cement production is reserved. The Cement Allocation and Coordinating Organisation has offered a special allotment of 20,000 tonnes in favour of the Government of Mysore for purchase at public rates for the period July-Septem-, ber, 1966.
