Operate Transfer (BOOT) basis. The operations of Kakinada Deep Water Port have been handed over to private operator on Operate maintain share & Transfer (OMST) basis. The development of Nizampatnam and Machilipatnam Ports through public-private partnership is under consideration.

Road declared as NH in U.P.
