t[LicENCEs TO INDUSTRIES

322. SHRI RAM SAHAI: Will the Minister of INDUSTRY be pleased to state the names of the industries in whose cases Government have decided to grant licences and the names of those industries which have not been considered fit lor the grant of licences in view of the new situation arising out of the devaluation of the rupee ?]

उद्योग मंत्री श्री (डी० संजीवंया) : सरकार ने उन उद्योगों की कोई भी सूची तैयार नहीं की है जिनके लिये रुपये का अव-मूल्यन हो जाने से उत्पन्न नई स्थिति को देखते हुए उद्योग (विकास तथा विनियमन) अधि-नियम, 1951 के अन्तर्गत लाइसेंस स्वीकृत किये जाने चाहिएं या नहीं। फिर भी सामान्य प्रथा प्रत्येक छमाही में उन उद्योगों की एक सूचो, जिनको सामान्यत: औद्योगिक लाइ-सेंस मंजूर नहीं किये जाते तथा उन आवेदन-पत्नों के बारे में एक अन्य सूचा प्रकाशित करने को है जिनको गुणावगुणों के आधार पर औद्योगिक लाइसेंस देने के लिये विचार किया जाता है।

t[THE MINISTER OF INDUSTRY (SHRI D. SANJIVAYYA) : Government have not drawn up any list of industries to which licences under the Industries (Development and Regulation) Act, 1951 may or may not be granted in view of the new situation arising out of the devaluation of the rupee. It has, however been the normal practice to publish every half-year a list of industries in respect of which industrial licences are not normally granted and another list in respect of which applications (or grant of industrial licences are considered on merits.]

PRODUCTION ON NITROPHOSPHATE

323. SHRI R. T. PARTHASARA-THY : Will the Minister of MINES AND METALS be pleased to state :

(a) whether the nitrophosphate produced at Neyveli is of a superior variety and of the same quality as produced at the Trombay unit of the Fertiliser Corporation of India;

(b) whether field research has revealed that the Neyveli nitrophosphate is a good substitute for ammonium sulphate or super phosphate; and

(c) what is the estimated quantity of nitrophosphate that is expected to be produced per annum at Neyveli?

THE MINISTER OF MINES AND METALS (SHRI S. K. DEY): (a) Nitrophosphate is not produced at Neyveli. Preliminary field trials were conducted at Aduthurai Rice Research Station in Thanjavur District (Madras State) with Nitrophosphate experimentally produced in the Neyveli Project Laboratory.

(b) They indicate that Nitrophosphate is as efficient as Ammonium Sul-phate-cH/n-super phosphate.

(c) Does not arise.

DISLOCATION OF TRAIN SERVICES ON WESTERN RAILWAY

(a) whether it is a fact that train services on the Western Railway were dislocated on the 22nd June, 1966 as hundreds of irate commuters damaged Railway property and squatted on the tract at Bassein Road Station; and

(b) if so, what are the details in this regard ?
