#### LAND FOR INDUSTRIALISTS IN DELHI

471. SHRI B. N. MANDAL :  
SHRI JAGAT NARAIN :

Will the Minister of WORKS, HOUSING AND URBAN DEVELOPMENT be pleased to state :

(a) whether it is a fact that Government are considering to review the implementation of the Delhi Master Plan to help the industrialists in the Union Territory of Delhi by allotting them more land for industrial units; and

(b) if so, the reasons for making this concession to the industrialists when there is already an acute shortage of land for housing in Delhi ?

THE MINISTER OF WORKS, HOUSING AND URBAN DEVELOPMENT (SHRI MEHR CHAND KHANNA) : (a) and (b) The Government is not considering a review of the Master Plan for Delhi to help industrialists by allotting them more land for industrial units. The areas where the industries can be located are already shown in the Plan. Industries which are now located in areas other than industrial areas are required to be shifted according to a phased programme. Noxious and hazardous industries have to be shifted first. For this purpose, the Government is also giving some inducement to the industrialists such as grant of loans

for construction of factory buildings and allotment of more land for expansion of the industry.
