#### **ELECTRONIC COMPUTERS FOR L.I.C.**

\*382. SHRI NIREN GHOSH : Will the Minister of FINANCE be pleased to state:

- (a) the additional foreign exchange requirement of the Life Insurance Corporation in introducing electronic computers as a result of devaluation of the rupee;
- (b) the additional hire charges to be paid to foreign companies as a result of devaluation; and
- (c) whether there is any proposal under Government's consideration to baa the introduction of these machines in the L.I.C. in view of the additional foreign exchange burden ?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI B. R. BHAGAT) : (a) and (b) Of the two electronic computers, one has already been purchased by the L.I.C. from I.B.M. and the purchase money paid. There is no question of any additional payment in this regard on account of devaluation. For the second computer which has not yet been delivered, L.I.C. has entered into a purchase agreement with the I.C.T. which *inter alia* provides that "the prices will be increased or decreased" if there is any change in the standard I.C.T. scales "between the date of contract and delivery". In any case, L.I.C. has not accepted any liability to make payment in foreign exchange, (c) No, Sir.
