In the Mahanadi delta area, geological I messages beyond the borders of India. mapping and gravity and magnetic surveys have been caried out. The surveys are to be continued.

Written Answers

In the south-eastern part of West Bengal, seismic surveys have ben carried out. The surveys are to be continued. Drilling of a deep well is being started.

- (b) On the basis of the available data, the prospects in the Cauvery basin appear to be better than those in the other areas mentioned under (a) above.
- (c) In the Cauvery basin, exploration is being carried out, intensively, with the help of two seismic parties, one structural drilling rig and one deep drilling rig. To intensify the exploration work, it is proposed to deploy one more deep drilling rig in this area.

In the south-eastern part of West Bengal, exploration is being carried out intensively with the help of four seismic parties and to follow up the results of the seismic surveys, a deep drilling rig is being put into operation.

RECOVERY OF UNLICENSED TRANSMITTER SETS

- *432. SHRI P. C. MITRA: Will the Minister of COMMUNICATIONS be pleased to refer to the statement laid on the Table of the House in connection with the answer to Starred Question No. 548 given in the Rajya Sabha on the 30th November, 1965 and state:

THE MINISTER OF STATE IN THE DEPARTMENTS OF PARLIAMENTARY AFFAIRS AND COMMUNICATIONS (SHRI JAGANNATH RAO): (a) 8 transmitter sets were reported to be in order.
Out of these 6 were capable, under favourable conditions, of sending

Information on the remaining 4 sets is being collected from the State Governments.

(b) The transmitter sets were manufactured in more than one country namely U. K., U.S.A., Holland and Japan. One was selfassembled. The required information in respect of one set is not available and this is being collected.

(b) Aden (4); Iraq (5); Lebanon (5): Jordan (23); Sudan (11); Syria (4): Trucial States in the Gulf area (1);Yemen (1); UAR (7).

RISE IN CENTRAL SALES TAX

- (b) if so, whether Government propose to modify the rates of the sales tax; and.
 - (c) what are the details of the **new** levies?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI JAISUKHLAL HATHI): (a) Yes.

(b) and (c) A statement is laid on the Table of the House.

STATEMENT

The rates at which Central tax may be levied on inter-State sales are prescribed by the Central Sales Tax Act, 1957. By an amendment of the Act, the rate of such tax on inter-State sales to registered dealers was enhanced from 2 per cent, to 3 per cent, with effect from the 1st July, 1966. Government do not propose to revise this rate.

The Act, however, empowers the State Governments, when it is necessary to do so in the public interest, to grant exemption from the payment of Central Sales Tax or to reduce the rate of tax, on such goods or class of goods and subject to such conditions as the State Government may specify by notification. In exercise of these powers. Central sales tax is levied at a concessional rate on certain categories of goods, re-exported from Delhi subject to certain conditions if such goods have suffered Central sales tax at the time of their import into this Union territory. The concessional rate was i per cent, from 1st July 1957 to 31st March 1963 when the normal rate of Central sales tax was 1 per cent, and was increased to 1 per cent, from 1st April 1963 when the normal rate of the tax became 2 per cent. There has been no further increase in the concessional rate with the increase in the normal rate to 3 per cent, from 1st July, 1966. Certain procedural difficulties experienced by the traders in Delhi in availing of the concession were brought to the notice of the Government and the question of making certain changes in the existing orders on the subject is under consideration.

THE DEPUTY MINISTER IN THE MINISTRY OF EDUCATION (SHRI BHAKT DARSHAN): (a) Yes, Sir.

(b) The National Fitness Corps being an All India Organisation, the scales of pay of its instructors cannot correspond with the scales of pay of State Physical Education Teachers.
