PETRO-CHEMICAL COMPLEX AT COCHIN

THE MINISTER OF PETROLEUM **CHEMICALS** (SHRI O. V. AND ALAGESAN). (a) and (b) There was no proposal to set up a petro-chemical complex as such at Cochin. Only the production of petro-chemical ammonia was planned and it is being implemented. A fertilizer unit with an annual capacity of 1,64,000 tonnes in terms of nitrogen is being set up near the Cochin Refinery based on naptha as feedstock.

ALL INDIA EDUCATIONAL SERVICE

548. SHRI D. THENGARI: SHRI SITARAM JAIPURIA:

Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether Government have decided to constitute the All India Educational Service; and
- (b) if so, what are the details of the scheme and the time by when the same would be introduced?

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI V. C. SHUKLA): Yes, Sir. (a)

(b) The Service is being constituted on the pattern of the existing All India Services. It will comprise of posts of and above the district level. (Each State will have a cadre and the needs of the Centre would be met by obtaining officers on tenure deputation from the States.) Recruitment at the initial constitution will be through selection by a Special Selection Board from amongst the State Service officers holding the posts encadred in the Service. Recruitment at the maintenance stage will be mainly through ries where disputes arose?

an open all-India competitive examination and partly through promotion of of the State Education Services.

Though all the State Governments have agreed in principle to the constitution of the Service, yet matters of detail, such as, particulars of posts to be encadred, rates of remuneration, promotion inclusion of teaching and research posts and framing of rules regulating recruitment, promotion, etc., are under consideration in consultation with them. In order to provide for necessary legislation the creation of this Service, All India Services (Amendment) Bill. 1965 has also been introduced in the Lok Sabha. It is not, therefore, possible to indicate at this stage any definite date by which the Service will actually be constituted.
