SHRI M. C. SHAH: Especially when India has taken some interest in this growing technology, may I know whether the Government intends to go in for some experimental work even though for the present the cost may be prohibitive?

Written Answers

SHRIMATI INDIRA GANDHI: Sir, experimental work is going on even now.

SHRI M. C. SHAH: May I know the place where it is going on?

SHRIMATI INDIRA GANDHI: At the Atomic Energy Establishment in Trombay.

SHRI P. K. KUMARAN: May I know whether the cost structure revealed by the study has been compared with the cost of supplying water to the Bombay area now?

SHRIMATI INDIRA GANDHI: The cost, as I have said, is very much greater by this process of desalination. It becomes cheaper if such a plant is attached to an atomic reactor or plant.

SHRI SANTOKH SINGH: Is this scheme being carried on somewhere else in any part of the world, and may I know the cost also, because this cost seems to be really very prohibitive?

SHRIMATI INDIRA GANDHI: I do not know of other places where it is carried on. But I do know that experiments have taken place in the United States and—I stand to correction—perhaps also in Japan.

SHRI N. SRI RAMA REDDY: Is there any possibility in the near future of reducing the cost and bringing it down to the level at which water is at present available to the various cities?

SHRIMATI INDIRA GANDHI: I should not think this should be possible in the near future.
