Kerala and Andhra Pradesh has been completed and the new factory proposed in Madhya Pradesh has been set up. On present estimates, this is likely to be towards the end of the Fourth Plan period. The exact location of the plant has not yet been decided. The initial capacity of this unit is expected to be Rs. 5 crores worth of machine tools a year.
