STATEMENT

- (a) The All India Handloom Board in its 25th meeting held on 30th May, 1966 has recommended that the rebate scheme on sale of handloom cloth produced by cooperatives should b2 continued in its present form during 1966-67.
- (b) Central assistance to State Governments on development of handloom industry is given on the basis of actual expenditure incurred and furnished by them on this account, Figures of expenditure are furnished as a whole for the handloom industry, and separate figures for individual schemes such as rebate etc. are not furnished. Hence, no estimate of the expsnditure involved on rebate is readily available; the information is being collected from the State Governments.

EFFECT OF DEVALUATION ON COAL INDUSTRY

- (a) whether it is a fact that coal industry has been affected by devaluation:

- THE MINISTER OF MINES AND METALS (SHRI S. K. DEY): (a) and (b) The impact of devaluation will be reflected in the future imports of machinery, equipment and spares needed for coal mining in- j dustry. The coal prices are under review when all relevant aspects will be taken into account.
- (c) India's export trade in coal has been only marginal. The effect of devaluation on export of coal is not yet perceptible.
