## EXPORT LICENCES TO CANNED FRUIT

- 628. SHRI RAMPRASANNA RAY: Will the Minister of COMMERCE be pleased to state:

- (b) Export of mango slice in brine is allowed to exporters to the extent of 66-2/3% of their export performance during 1965-66. No licence is, however, required for exports.

- (d) The number of importers in various countries is too large to be mentioned. However, the main importing countries are U.K., U.S.A., U.S.S.R., Switzerland, France, Iraq, Kuwait, Saudi Arabia and Malaysia.
