

RANJIT AND LODHI HOTELS

*642. **SHRI M. S. OBEROI** : Will the Minister of **WORKS, HOUSING AND URBAN DEVELOPMENT** be pleased to state :

(a) whether it is a fact that the Ranjit and Lodhi Hotels in New Delhi are running at a loss; and

(b) if so, the total accommodation in these hotels and the average daily occupancy of rooms during the last three months ?

THE MINISTER OF WORKS, HOUSING AND URBAN DEVELOPMENT (SHRI MEHR CHAND KHANNA) : (a) The Ranjit Hotel started functioning only from the 7th November, 1965 and the Lodhi Hotel from the 15th September, 1965. Since they have not yet completed the first year of their working, it is too early to assess their financial results.

(b) The effective accommodation available and average occupancy for the last three months in the hotels were :—

SALE OF HABIT-FORMING DRUGS

THE MINISTER OF HEALTH AND FAMILY PLANNING (DR. SUSHILA NAYAR) : (a) Yes, Sir.
