  - Articles issued to units and formations on vouchers are shown in the Station Furniture Distribution Ledger.
  - Quarterly Inspection is carried out by the MES in collaboration with unit representative of furniture in unit lines.
  - 4 Annual Stock Taking of the furniture held on charge is carried out by actual counting in the unit lines by the MES and unit representatives.
  - 5 Furniture rendered unserviceable through fair wear and tear is surveyed off in accordance with the prescribed procedure.

The necessity for any further steps will be examined on receipt of the Court of Enquiry proceedings.

THE PRIME MINISTER (SHRIMATI INDIRA GANDHI): (a) and (b) The Prime Minister wrote to her Cabinet colleagues in May last suggesting that the programmes of their visits to foreign countries may be limited to only those places which were considered absolutely necessary, and that their stay be as short as possible. No suggestion was made that the Ministers should cancel their lours altogether.
