(v) The premises from which cholera cases are reported are disinfected. Regular disinfection of wells is being carried out and the municipal water is checked at the distribution points for presence of free chlorine and for coliform organism.]

DEATHS DUE TO HEART FAILURE

88. SHRI T. V. ANANDAN: Will the Minister of HEALTH AND FAMILY PLANNING be pleased to state whether Government have made any investigation into the causes of deaths due to heart failure in the country?

THE MINISTER OF HEALTH AND FAMILY PLANNING (DR. SUSHILA NAYAR): Under the sponsorship of the Indian Council of Medical Research and institutions like the All India Institute of Medical Sciences, New Delhi, heart diseases are being investigated as part of their research activities. The main causes of deaths due to heart diseases are Coronary Thrombosis, Arterio-sclerosis and High Blood Pressure and Corpulmonale.

PAY-SCALES OF STENOGRAPHERS

- 89. SHRI D. THENGARI: Will the Minister of FINANCE be pleased to State:
- (a) whether it is a fact that the payscales of certain categories of stenographers in the Government of India offices have been recently revised and raised; if so, what are the original and the revised pay-scales, and on what grounds the increase has been determined; and

(b) whether any economy has been effected to curtail this expenditure?

THE MINISTER OF FINANCE (SHRI SACHINDRA CHAUDHURI):

- (a) Information is being collected and will be laid on the Table of the House as soon as it is available.
- (b) All proposals for deputation of Government officials abroad are strictly scrutinised by a Committee of senior Secretaries and ordinarily only such de putations are permitted as are unavoid able or are likely to lead to substantial saving in foreign exchange or relate to the defence effort or to training require ments. From the information so far available, it appears that expenditure in the foreign exchange on such deputa tions during 1965-66 was considerably less than that incurred in the preceding year.
