**INCREASE OF MOSQUITOES IN DELHI**

(a) whether it is a fact that there is a great increase of mosquitoes in Delhi and New Delhi; and

(b) if so, what steps Government have taken for their eradication ?

THE MINISTER OF HEALTH AND FAMILY PLANNING (DR. SUSHILA

NAYAR) : (a) and (b) There has been some increase of mosquitoes in Delhi and New Delhi. The National Malaria Eradication Programme is in operation in the Union Territory of Delhi since 1958. Anti-larval measures are being taken under this programme. Further remedial measures to tackle the problem are under consideration. Eradication of mosquitoes as such is, bouever, not envisaged.

**COMPENSATION FOR PRICE RISE TO  
GOVERNMENT EMPLOYEES**

Will the Minister of FINANCE be pleased to refer to the reply given to Unstarred Question No. 50 in the Rajya Sabha on 7th May, 1966 and state.

(a) whether the scheme to give compensation in kind to Central Government Employees against price rise has since been finalised by the Government;

(b) if so, the details thereof; and

(c) what is the total extent of increase in the cost of living index since the

Second Pay Commission's Report which has not been set off by the increases granted to Government Employees (category-wise) from time to time, in the Dearness Allowance payable to them?

THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRI L. N. MISHRA): (a) to (c) A statement is laid on the Table of the House.

#### STATEMENT

(a) and (b)\* A tentative scheme for making available to Government employees foodgrains and certain other essential commodities at subsidised prices through a chain of co-operative stores or fair price shops was discussed with representatives of employees. It has, however, not been pursued as it was not received well and the indication was that, even if implemented, the scheme would not do away with the necessity of paying dearness allowance in cash.

(c) The All-India Working Class Consumers Price Index stood at 115 (base 1949=100) when the Second Pay Commission made its recommendations. In accordance with these recommendations, the rates of dearness allowance have been reviewed and revised each time the 12-monthly average of the Index rose by 10 points. It is not possible to indicate precisely the extent of increase in the cost of living Index which has not been set off by these increases because the various fringe benefits admissible in addition to dearness allowance, such as house rent allowance, medical reimbursement, educational assistance, etc., also absorb a portion of the price rise which is reflected in the Index movement. Without taking these additional benefits into account, the percentage of neutralisation effected by the dearness allowance now admissible is as follows :—

For those drawing pay above Rs. 600, the flat rate of Rs. 100 p.m. is allowed, *ad hoc*.

NOTE.—The percentages indicated above relate to the total rise in the Index level upto 165. The percentages adopted on the last occasion for the rise of 10 points were 75 per cent, for the first 3 slabs and 60 per cent for the fourth slab.

Certain changes are likely to be made in the Plan outlay, as a result of devaluation. As the Draft Outline is still in preparation, it is not possible to give the details.
