(घ) सरकारी प्रतिनिधि ने जो रिपोर्ट पेश की थी, उसमें दूसरे देशों में इस समस्या के स्वरूप के बारे में, इस समस्या को सुलझाने में उनके अनुभव तथा भारत को उसकी उपयोगिता के सम्बन्ध में, विधायी उपायों के तथा इस विषय में उनके उपागम के बारे में वर्णन है।

[THE DEPUTY MINISTER IN THE DEPARTMENT OF SOCIAL WELFARE (SHRIMATI MARAGATHAM CHANDRASEKHAR) : (a) Two, one of whom was an official and the other a non-official.

(b) The Government of India sanctioned Rs. 550 for the subsistence charges of the official delegate at Rome. His international travel costs were borne by the I.L.O. in connection with some other International Conference in Europe.

The Government did not meet any part of the cost of participation of the non-official delegate.

(c) Such an arrangement enabled the concerned delegates to exchange views and to share directly experience on the subject with others.

(d) The report submitted by the official delegate lists the nature of the problem as it exists in some other countries, their experience of dealing with it and the usefulness that India can draw from them in framing its own schemes, legislative measures and approach on the issue.]

#### RE-ORGANISATION OF THE L.I.C.

\*746. SHRIMATI TARA RAMCHANDRA SATHE: Will the Minister of FINANCE be pleased to state:

(a) whether it is a fact that Government had recently appointed Mr. Khaira, an I.C.S. Officer, to consider the question of re-organisation of the L.I.C;

(b) if so, whether he has submitted his report to Government; and what are the details thereof; and

(c) what are the reactions of Government thereon ?

THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRI L. N. MISHRA) : (a) Yes, Sir. Shri S. S. Khera, formerly Cabinet Secretary, was appointed in January 1965 as Chairman of the one-man study team to review the problems of Life and General Insurance.

(b) and (c) Shri Khera has so far submitted the results of his studies on administration of the L.I.C, the problem of investment of life funds and the problem of reinsurance. He has to cover some more aspects of insurance. The Govt. would take decision on the results of Shri Khera's studies when he completes his assignment.

(e) how many of them have resigned before completion of two years' service ?

THE MINISTER OF HEALTH AND FAMILY PLANNING (DR. SUSHILA NAYAK) : (a) According to information available, the number is 3726.

(b) 2368.

(c) A statement containing information regarding the qualifications and pay scales for the Extension Educators for Family Planning obtaining in the States is placed on the Table of the Sabha.

(e) According to information received from the States, 6 Extension Educators have resigned before completion of two years' service.

#### AMERICAN AID TO INDIA

\*749. SHRI SITARAM JAIPURJI: Will the Minister of FINANCE be pleased to state :

(a) whether the attention of Government has been drawn to a news-item published in the *Hindustan Times* dated 5th August, 1966 to the effect that American aid to India and Pakistan will be related to progress towards securing peace between them; and

(b) what is the reaction of Government thereto ?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI B. R. BHAGAT) : (a) Yes, Sir.

(b) The Government has not received the text of the testimony referred to in the news-item, before the House of Representatives Appropriations Sub-Committee on Foreign Aid. However, the reported testimony is not a new development in U.S. policy regarding aid to India and Pakistan. In his message on foreign aid to U.S. Congress on February 1, 1966, the U.S. President said : "The progress of reconciliation—first at the United Nations and then at Tashkent—holds promise that these two great countries have resolved on a course of peace. My request for development loan funds is made in the hope and belief that this promise will be fulfilled".

#### RUPEE VALUE IN TERMS OF POUND

\*750. SHRI G. MURAHARI: SHRI S. S. MARISWAMY

Will the Minister of FINANCE be pleased to state :

(a) whether the attention of Government has been drawn to the fact that since devaluation the value of the rupee in terms of Sterling in the market is Rs. 40 to the Pound; and

(b) if so, what is Government's reaction in this regard ?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI B. R. BHAGAT) : (a) Yes, Sir. Government are aware of the existence of unofficial quotations for Sterling. According to these, the quotation in terms of pound sterling was Rs. 30.86 on 11th August, 1966 for rupee notes in the London market.

(b) Government is making every effort to reduce the scale of these unofficial transactions by stricter enforcement of Exchange Control Regulations.

#### RESIGNATION BY DOCTORS IN IRWIN HOSPITAL

Will the Minister of HEALTH AND FAMILY PLANNING be pleased to state :

(a) whether the eminent doctors attached to the Irwin Hospital, including Dr. Sen and Dr. Jain have tendered their resignations;

(b) if so, what are the reasons for the same; and

(c) how many honorary doctors attached to this hospital have resigned in the past?

THE MINISTER OF HEALTH AND FAMILY PLANNING (DR. SUSHILA NAYAR) : (a) Dr. Sen and Dr. Jain tendered their resignations. While the resignation of Dr. Jain was accepted, Dr. Sen did not press his resignation and it was not forwarded to the Delhi Administration.

(b) These Honorary Medical Officers objected to the enforcement of the rules pertaining to their appointments.
