

Office. Three Medical Officers have been appointed as part-time employees at the Central Office.

Corporation has a special Research Section in its Actuarial Department at the Central Office for carrying out various investigations, including medico-actuarial investigations.

Services of all the medical officers who were salaried employees of the erstwhile insurers and who opted to join the Corporation were retained.

**SHRIMATI TARA RAMCHANDRA SATHE :** Sir, the answer to part (b) of the question has not been given in full. I had asked: How many medical men are there now in the L.I.C. who were working in the old units or companies. And I want to know also whether those who have joined the LIC, are they entrusted with the same medical work as they were doing with their respective companies before the formation of the LIC.

**SHRI T. T. KRISHNAMACHARI :** It is very difficult to say who is doing what particular work, because the total number of medical referees maintained by the various corporations or companies before the LIC came into being was about 26,000 and after scrutiny over a period of time the number has been reduced to 9,000. There must be a certain amount of additional work given to these people. I cannot definitely say who is doing what type of work.

**SHRIMATI TARA RAMCHANDRA SATHE :** If I am right, there are very few medical men from outside who do the same job or type of work under the LIC now. How many are they who are actually employed by the LIC ? That is my question. I do not think it will be anything like 26,000 or 9,000.

**SHRI T. T. KRISHNAMACHARI :** There are only three medical employees who have opted to work for the LIC and who were working with the other insurance corporations before.

**SHRIMATI TARA RAMCHANDRA SATHE :** Is it not necessary to supervise the work done by the medical men who are not employees of the Corporation, especially when medical examination is a very important factor in life insurance ?

**SHRI T. T. KRISHNAMACHARI :** As a matter of fact, as the hon. Member is perhaps aware, there are two types of medical men. There are those who actually examine the applicants for insurance, and then you have the senior medical officers going through these reports. But they are not employees as such. They are paid on their work. That kind of supervision is being maintained without having them as employees.

**SHRIMATI TARA RAMCHANDRA SATHE :** Coming now to the Statement, Sir, I would like to say that the actuaries are well informed in the mathematical part of the supervision. But how can we expect medical work to be done by persons who do not know anything about the medical part of the work and so are unable to judge about the lives insured ? Will the Government see that a special medical section of the Corporation with medical personnel is started ?

**SHRI T. T. KRISHNAMACHARI :** I would not say, Sir, offhand without getting further information whether in the actuarial section which is in charge of maintaining the standards, we have no medical men. May be there are, but I will not say anything definitely. But the fact is since mortality rates and other things have to be decided, the proper section is the actuarial section. Whether there are medical men employed or not I am not in a position to say.

श्री राम सहाय : क्या मैं मंत्री महोदय से जान सकूंगा कि अभी हाल में इमरजेंसी की वजह से कोई आदेश इस प्रकार के दिये गये हैं कि हाउसिंग स्कीम के लिये कोई पैसा अभी नहीं दिया जाय।

श्री मेहर चन्द खन्ना : यह तो नहीं है असल बात यह है कि इस साल हमें 15 करोड़ रुपया एल० आई० सी० से मिलना था 60 करोड़ रु० का प्रबन्ध तीसरी योजना में था, 45 करोड़ मिल चुका, 15 करोड़ मिलना था। हमने एल० आई० सी० से कहा कि फाइनेस मिनिस्ट्री से पूछे कि आया इसमें कोई कटौती तो नहीं लगाने वाले हैं, कई राज्य सरकारो को लिखा और पूछा कि आपके कमिटमेंट्स कितने हैं और उन कमिटमेंट्स के मुताबिक अगर काम चल रहा है, मकान बन रहे हैं रुपया देना है तो फिर तो कटौती हो नहीं सकती, कुछ बचत हो सकती है तो की जायगी। लेकिन फाइनेस मिनिस्ट्री ने यह जरूर कहा है कि नये कमिटमेंट में एन्टर होने से पहले हमें उनको कमल्ट करना होगा, मशविरा करना होगा।
