have to give them a little more salary. But it is not correct to say that it is more than the Central Government salary scales.

Oral Answers

श्रीमती सीता युद्धवीर : श्रीमन्, राशनिंग होने के बाद सफेद गेहूं और लाल गेहूं के क्या दाम तय किये गये हैं ?

SHRI D. R. CHAVAN: That question does not arise out of this question. Thi3 is concerned with the overhead charges of the Corporation for handling the food-grains.

SHRI DEOKINANDAN NARAYAN: May I know what particular expenditure of the Corporation is going to be charged on the cost price of the cereals 7

SHRI C. SUBRAMANIAN!: There are two aspects. There are certain incidentals which are inevitable, whether it is handled by the Food Corporation or by any agency, for example, railway freight and various other things. As far as the administrative charge is concerned, when it was being done by the governmental agency, we allowed 78 paise per quintal, whereas for the Corporation we are allowing only 42 paise per quintal.

SHRI N. SRI RAMA REDDY: At this rate is it going to be a "no profit, no loss" organisation?

SHRI C. SUBRAMANIAM: This is a '< commercial organisation. It may incur loss or it may have some profit.

DROUGHT CONDITION IN PUNJAB

*648. SHRI I. K. GUJRAL: Will the Minister of FOOD AND AGRICULTURE be pleased to s'lte:

- (a) whether the Government of Punjab has conveyer to the Government of India about the existence of serious drought condition in that State and

THE DEPUTY MINISTER IN THE MINISTRY OF FOOD AND AGRICULTURE (SHRI SHAH NAWAZ KHAN): (a) Punjab Government have reported drought conditions in some parts of Hissar and Mahendragarh Districts.

(b) Necessary relief measures are being taken.

SHRI I. K. GUJRAL: May I ask the hon. Minister if any estimate has been made as to how much will be the short-fall in production of cereals compared to last year due to drought conditions?

SHRI SHAH NAWAZ KHAN: I presume the State Government must have made estimates themselves. They have not communicated that to us. They do it normally district-wise.

SHRI I. K. GUJRAL: Overall.

SHRI SHAH NAWAZ KHAN: I will have to find it out from the State Government. If the hon. Member will give me notice, I will find it.

MR. CHAIRMAN: The faith of the House in estimates seems to be touching.

SHRI I. K. GUJRAL: May I ask the hon. Minister if he it in a position to tell us if any steps have been taken to meet the drought conditions? I know he cannot make it rain, but he can do something sise. For instance, have any water pumps | been energised and, if so, how many?

SHRI C. SUBRAMANIAM: Pumps have been energised, but I cannot give the; axact number. In addition to that we are supplying a large number of diesel pump sets, mobile sets, so that whatever water resources are available could be properly utilised. Yesterday I was in Chandigarh. They are taking all measures to see that the drought conditions are to a certain extent relieved.

SHRI I. K. GUJRAL: Has the hon. Minister been informed at Chandigarh yesterday that the waterlogged areas of Punjab I will improve due to the drought conditions? SHRI C. SUBRAMANIAN!: There are certain benefits arising out of drought also, that is, the waterlogging conditions might improve; but the water availability has decreased. That is likely to affect the production.

We are trying to rectify them and to utilise this organisation to the best advantage possible as a voluntary agency to help in food production.

SHRI SUNDAR MANI PATEL: What are the deficiencies suffered by the Bharat Krishak Samaj 7

SHRI C. SUBRAMANIAM: In the past there were some deficiencies with regard to the maintenance of accounts and accounting for certain receipts too. All these things are being rectified.

SHRI DAHYABHAI V. PATEL: Usual Congress deficiencies.
